

# MISSISSIPPI LAKE PLAN PROCESS

The Centre for Sustainable Watersheds (CSW) has partnered with the Mississippi Lakes Association (MLA), French Planning and Mississippi Valley Conservation (MVC) on the development of a Mississippi Lake Plan. The goal of Lake Plan is to identify, protect and restore the natural, physical and social integrity of Mississippi Lake's ecosystem.

## WHAT ARE THE STEPS?

<b>Background Work (2011-2014)</b>	<ul style="list-style-type: none"><li>✓ Determine the need for a Mississippi Lake Plan (done at Annual General Meeting in June 2011)</li><li>✓ Establish terms of reference, work plan and organizational structure</li><li>🕒 Determine values surrounding the lake and the issues that threaten them using community surveys</li><li>🕒 Complete research for the "State of the Lake/Watershed" report</li><li>• Complete a nutrient budget and lake capacity models using Total Phosphorous (TP) as an indicator</li><li>🕒 Complete the "State of the Lake Watershed" report for reference purposes</li></ul>
<b>Plan Preparation (2014)</b>	<ul style="list-style-type: none"><li>• Establish a "Mississippi Lake Vision and Values"</li><li>• Establish goals and objectives for the Mississippi Lake Plan and develop implementation and action strategies.</li><li>• Produce the Mississippi Lake Plan</li><li>• Distribute the Lake Plan to community members and partners for review</li></ul>
<b>Implement (2015- beyond)</b>	<ul style="list-style-type: none"><li>• Obtain formal endorsement for the Mississippi Lake Plan from community</li><li>• Adopt an implementation strategy and actions</li><li>• Implement any needed monitoring strategies</li><li>• Adopt a formal review schedule of the Lake Plan</li></ul> <p>✓ = completed 🕒 = currently in progress</p>

5. **Mississippi Lake Plan Draft – March 1<sup>st</sup>, 2015**
6. **Mississippi Lake Plan Final Document – June 1<sup>st</sup>, 2015**
